CALL TO ACTION!

Ohio Lawmakers Make Another Push for Senate Bill 83

Despite ongoing massive public opposition and the removal of SB 83 language from the budget conference committee due to lack of support in the House of Representatives, the legislature plans to take up the bill again this fall.

Senator Cirino told Columbus Dispatch that he is planning to remove staff unions from the no-strike provision of the bill, leaving only faculty unions without the ability to strike. The pending version of SB 83 in the House also prohibits us from bargaining over certain subjects (tenure, retrenchment, workload, and evaluations). Under the guise of not wanting to disrupt student learning, the true intent of these portions of SB 83 is to weaken the power of faculty to advocate for fair working conditions, which are student's learning conditions.

Last week, we and unions across the labor spectrum signed a letter that was sent to all members of the Ohio House of Representatives. The letter sends an important message to the House that all labor unions oppose any attacks on our collective bargaining rights.

We are asking you to fight back once again and encourage the House of Representatives to reject SB 83

In 1977, Tri-C faculty made a significant step towards advocating for our collective interest and voted to accept the AAUP as their collective bargaining agent. Today, as was back then, faculty remain at the core of our college's mission, with a shared commitment to providing accessible high-quality education for every member of our diverse community.

As Tri-C marks its 60th anniversary, our CCC-AAUP Chapter affirms our role to promote and protect our faculty members so that we continue to meet the mission of our college.

Some of our current priorities for this year include: engage in strategic conversations with administration about the academic restructure (New School Model), monitor and participate in committees created around the National Academic Advising Association (NACADA) processes, and identify faculty priorities and concerns for our 2025 contract.

In addition, as you know, last academic year the college held an Ideas Festival and selected three proposals.

AAUP Campus Leadership

Justin Miller, East David Bernatowicz, Metro Lemuel Stewart, West Bridget Kriner, Westshore The CCC-AAUP contended that allowing all constituent groups to vote on proposals impacting our contract is inappropriate as it might place the College at odds with our existing agreement. The CCC-AAUP raised a firm objection to two of the ideas that have risen for consideration. The Online Campus and Welcome Mat to Graduation Cap proposals contain items that potentially conflict with our existing contract.

In response to our objection, Dr. Baston assured the Chapter that the College will abide by its legal obligation to bargain with the CCC-AAUP prior to implementing the proposals. The AAUP will be involved in further discussions.

As we begin a new school year, I want to thank all of you for your commitment and dedication to union solidarity. I look forward to working with all of you toward our shared goals.

The Workplace Core Curricula

As part of our current CCC-AAUP contract, we have agreed to participate in the Workplace Core Curricula.

The Workplace Core Curricula consists of the seminars outlined below (see side letter SL-8 of the Agreement between CCC and the CCC-AAUP). The content was jointly identified by the union and administration to be critical to the College's workplace environment. The Workplace Core Curricula consists of the following:

- Legal Issues/Harassment and Discrimination
- 2. Student Affairs Code of Conduct
- 3. Civility
- 4. Workplace Safety and Violence
- 5. Student Success
- 6. Refresher Course

Refresher Course: If you completed all five (5) full modules during previous contract cycles, you do not need to take the full modules again. You only need to complete the Core Curriculum Refresher Course, which is offered asynchronously in Blackboard.

The Refresher will take approximately three (3) hours and you will have two (2) weeks to complete.

The Refresher will be offered multiple times per semester, and you will have through the end of the 2022-2025 contract cycle to complete the course.

If you have already completed the Refresher Course between Spring 2022 and Summer 2023, you have met the requirements and do not need to complete the Refresher again until the new contract cycle. You will earn five (5) service credits for completing the Refresher Course.

Fall 2023 Refresher Course Dates:

- 1. Monday September 18th Sunday October 1st
- 2. Monday October 16th Sunday October 29th
- 3. Monday November 6th Sunday November 19th
- 4. Monday November 27th Sunday December 10th

Instructions to Complete the Refresher Course:

- 1. Register in the Talent Engagement Center (TEC) by searching FDEVW1016.
- 2. The Refresher Course will automatically populate in your Blackboard course list on start date.
- 3. Complete the course during the two-week timeframe. Successful completion is defined by completion of each video quiz with a score of at least 80%.
- 4. Attendance will be updated in TEC after your completion.
 5. Following completion of the Refresher Course, faculty can choose to self-enroll into a course content Blackboard site to have continuous access to the materials for the academic year.

Fall Commencement

This year our Fall Commencement will take place on Thursday, December 14th, which may overlap with some final exam schedules. If you are scheduled to administer a Final Exam on Thursday evening of Dec.14th, you are advised to proceed with the Final Exam. Your administration of the exam will substitute for your contractual obligation to participate in one of our two commencement ceremonies. You will not be required to participate in the ceremony scheduled for Spring Semester 2024.

Non-Instructional faculty scheduled for a regular shift during Fall Commencement are also exempt from the contractual obligation to participate in either graduation ceremony.

With respect to your students, if you are administering a Final Exam on Thursday evening, and you have a student in that course who is graduating, you are encouraged to make arrangements so that the student may complete the Final Exam and participate in the Commencement ceremony.
